## **TERRY DOWLE ELECTED**

## President of the British Columbia Association of the Appraisal Institute of Canada

Terry has been involved in the Real Estate Consulting industry in the Metro Vancouver and Fraser Valley regions since 1989. He was elected to the AIC-BC Board of Directors in 2013 and previously served as a representative of the Vancouver Chapter Committee, AIC-BC Provincial Board of Examiners, and as AIC-BC 1st Vice President. In addition to his AIC designation, Terry has been awarded several real estate designations from Langara Community College and the University of British Columbia, including his Associate Broker and Advanced Real Estate Management licenses.
